The European emission trading system (EU ETS) is a central climate protection instrument of the EU. In 2021, the fourth trading phase began with some innovations in the system along with a tighter emissions cap. The Fit-for-55 package set the course for a big overhaul of the entire EU ETS (inclusion of the maritime industry, introduction of CBAM, new EU ETS II for buildings and road transport). In addition, the national emission trading system (nEHS) exists in Germany and puts a price on further emissions.
